# **Proposed 2015 Budget**

When developing this year's proposed budget, the Board of Directors was guided by three priorities:

- 1. Ensure that current vital ministry programs are all adequately funded.
- 2. Provide substantial new funding for a big media campaign later this year. The goal will be to share word about our church in a sustained, professional media campaign, so we can welcome others who long for what we offer a warm, inclusive, nonjudgmental Christ-centered church!
- 3. Provide substantial new funding for building maintenance, so we don't keep deferring much needed repairs and upgrades. For example, the exterior of our building desperately needs painted, and the carpeting in the social hall is old and worn.

It's because of everyone's generous response to the October/November stewardship drive that the Board is able to present a budget proposal that meets the foregoing objectives. We believe this year's budget will propel us out of the sustaining mode and into the growth mode!

### Base Budget and Budget Steps

For those who are new, here is some basic information you'll need to understand the budget proposal. Each year, the Board proposes a "base budget." The "base budget" represents what we can afford with giving at its current level. Beyond that, the Board also proposes "budget steps." These "budget steps" identify additional initiatives we hope to activate as giving grows during the year.

Once approved, the base budget goes into effect immediately. Thereafter, the Board is then authorized to activate budget steps if, and when, giving growth will support those steps.

• This year's proposed base budget is sufficient to adequately fund all current ministry programs, while also adding \$2,500 for our 2015 media campaign and \$5,000 for building maintenance and upgrades.

- Budget Step 1, if reached, will add another \$2,500 for our 2015 media campaign and another \$2,500 for building maintenance and upgrades.
- Budget Step 2, if reached, will add yet another \$2,500 for our 2015 media campaign and yet another \$2,500 for building maintenance and upgrades.

### **Explanatory Notes for Budget Proposal**

The notes below correlate to specific line items in the proposed budget, which begins right after these notes. These notes are meant to provide background information. The Board will also be happy to take any questions at the Congregational Meeting.

**Other Income.** This line item includes income from sources other than donations from the congregation. Examples are rental payments from outside groups using our building, interest earned on bank accounts, fees from discipleship classes, paper recycling, etc.

**Designated Reserve Funds.** Occasionally someone will make a donation that they designate for a specific purpose. For example, someone may give a large one-time donation to fund new media equipment. Or someone may make special donations to support our missions work. This is the first year we are showing a line item for designated gifts. Our goal is to give you a better idea of the amount of funds we receive with special designations.

Advertising. This is the line item that will be used to fund our special 2015 media campaign. If we are able to reach Budget Step 2, we will be able to spend up to \$10,000 on our media campaign. In addition, outside the current budget proposal, we have already received \$12,000 from a bequest by Joe Hardesty that is reserved for the media campaign. The Board is also pondering holding another Art Auction in 2015. If that occurs, it could raise another \$10,000. If all these objectives are met, we will be able to invest about \$30,000 in a major media outreach campaign. This is gonna be big! We're gonna "let our light shine," just like Jesus said!

Bank Charges. We switched banks this year and anticipate slightly lower charges.

**Building Maintenance/Repairs.** This line item funds routine maintenance and small, incidental repairs.

**Building Major Repair Reserve.** This line item is new and is meant to better position us for periodic large repair expenses. We're talking about things like a new air conditioning unit or furnace, painting the building exterior, reroofing the building, replacing worn carpet, etc. In the past, these occasional major repairs have been budget busters. As a result, we've had a tendency to put off major repairs long past when they were needed. With this budget proposal, we're going to try to be more responsible stewards of our building.

**Conference.** Every year we set aside a small amount of money so we can afford to send voting delegates to our denomination's General Conference. General Conference occurs once every three years. The next Conference is in 2016.

**Congregational Care System.** This line item funds our annual fee to the company that provides and maintains the software system that enables us to track the attendance, activity, and special needs of people in our congregation, so we can provide the best possible loving care.

**Guest Speaker Expenses.** No funds are allocated to this line item since we're not planning to fund the travel of any outside speakers this year.

**Mortgage.** We refinanced our church mortgage this past year at a much lower interest rate, resulting in substantial savings.

**403(b) Employer Contribution.** This line item reflects our church's matching contributions to our employees' retirement plans. The church matches the first \$100 each employee contributes to his/her retirement account monthly.

HR Outsourcing. This line items reflects fees we pay to an outside payroll processor.

**Salary Expense.** The Board of Directors periodically compares our staff salaries to those of similarlysized churches, using a nationally respected survey source. *Currently, our staff salaries lag behind similarly-sized churches by about 20%.* Gradually, over time, as giving permits, we are closing this gap.

**Media Team.** Media team expenses were higher than usual last year because we received a special designated contribution to purchase some much needed media equipment. For 2015, we have increased the media budget slightly over the prior year's budget to better keep pace with technology and equipment needs.

**Member Care Gatherings.** This new line item is meant to fund the cost of food for bimonthly dinners for members of the church hosted by Pastor Jeff. The goal is to be able to have an intimate small-group conversation with every active member of the church at least once every couple years, starting with the longest-serving members and working backward through the membership roll.

**Pastoral Training Program.** Both of the students who were in our Pastor Training Program, Justimore Musombi and Graham Melendez, have had to take breaks from seminary for financial reasons. Both are working full-time jobs and saving funds for an eventual return to seminary. As a result, we have suspended our Pastoral Training Program. Going forward, our church will continue to serve as a site for seminary students to do their field education work, but we do not plan to resurrect our intensive supplemental Training Program. That means we anticipate no expenses for Pastoral Training this year, and we will not receive an MCC Tithe Credit for those expenses.

**Missions (Navajo/Sudan/Guatemala).** The "actual 2014" column for this line item shows our total investment in missions last year, \$24,749. About half that came from the weekly giving of our congregation, and the remainder came from designated donations. For example, when church members go on missions trips, they pay a portion of their trip costs out-of-pocket, which gets recorded as a designated donation. We expect a similar pattern to occur this year, allowing us to maintain our current level of missions outreach.

**MCC Denominational Tithes.** Each year we pay a denominational assessment equal to 12% of our income. This is required for us to continue as a member congregation in MCC.

Alarm. We have switch our alarm monitoring company, netting substantial savings.

Gas/Water/Sewer. The increase in this line item is based on meter readings.
